## The Prez Sez

This will be my last PS for this administration!! These two years have certainly passed very quickly and while a lot has been accomplished, a lot remains to be done. Please lend your support to the new administration as they will be trying to accomplish some great things for the club and all of it's members. At the last Board meeting we put into writing some of the goals and formulated some controls for dealing with the potential income we are anticipating. I will not go into detail here but will state that 3 objectives are: extensive road work, relaying the flying site, and construction of a building big enough for year round flying, and as a meeting room.

But at this point there is a very large fly in the ointment. While I was able to negotiate some very good financial terms with Widmar, they were unwilling to meet our demands for restriction that protect our use of the property, so we are back to square one. Maybe I'll have some better news by the time of the meeting.

Frank G., Don S. and I conducted an audit a couple weeks ago and Don is comfortable accepting the figures that Frank has presented. I don't remember the exact figure, but we are approx \$136 ahead of where we were last year at this time. Thank you Frank, for keeping us on track.

It has come to my attention recently that there seem to be a few individuals flying regularly at the field who are not AGS members. Since this has not been a prob-

lem in the past, we have no special by-laws or field rules to refer to. It has always been understood that visitors from out of the immediate area would be welcomed for as long as they were visiting but "locals" were expected to join the club. A visit or two is certainly acceptable, but a season of using the facilities with none of the physical or financial responsibilities is unacceptable. It was also brought up that some non-member may have been given the lock combination, and this is CERTAINLY a violation of club expectations. The Board has discussed this matter and will be making some specific recommendations shortly so they can be implemented prior to next year's flying season.

I recently received note from Phil Nacamuli. He is a member of the Aeros. His note was one forwarded from a scout master requesting a flying demonstration from the scout's pond during their gathering at their facility on Oct 19th. I am going to try to attend. If anyone would like to accompany me, I would appreciate the company.

Two years ago I volunteered to be President for one primary reason, to get the stalled logging contract completed. Over 18 months had passed since the original presentation was made to the membership. Our new board of Directors got the job done and had \$12,000 in our bank account less than 45 days later. Six months later we spent \$2000 of that on some major road repair, and while that did buy us some time, there is more that must be done. It has now been about 9 months since we were first approached on the potential lease of our land for mineral rights. A lot of

Treas: Don Shugard


BMAL: Paul Slocum finishing the 2 year term that Rick Allabaugh was elected to last year

## **Proposed By-Laws Changes**

The Board of Directors will be making a motion for a proposed change to our current by-laws, last updated April 2008. The intent is to vote on this proposal at our next regular meeting. I remind you that our by-laws can be amended as follows:

### **Article XI - AMENDMENTS**

- A. Amendments may be made to the by-laws at any regular or special meeting of the membership, provided the members have all been notified in writing at least three (3) days in advance that an amendment is to be considered. Copies of the proposed amendment shall be provided to all directors or to any members who may request same. Approval shall be by two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.

Current **Article III Membership** Sub-article G:

A member in good standing is one who:

1. Maintains membership in the AMA
2. Is current with AGS dues, fees, and assessments
3. Participates in at least one of the activities listed below during the current year:
  - a. Flies at a club-sponsored event
  - b. Assists in running a club-sponsored event
  - c. Serves as an elected officer of the AGS
  - d. Contributes an article to the AGS newsletter
  - e. Participates in mowing the AGS field or other maintenance operations of the AGS property
  - f. Participates in a "show-and-tell" portion of a club meeting
  - g. Participates in any other club activity, as published by the Activities Chairperson, which is not mentioned above.

Proposed Changes:

G A member in good standing is one who:

1. Maintains membership in the AMA
2. Is current with AGS dues, fees, and assessments
3. **Participates in at least two of the activities listed below during the current year:**
  - a. Flies at a club-sponsored event
  - b. Assists in running a club-sponsored event
  - c. Serves as an elected officer of the AGS
  - d. Contributes an article to the AGS newsletter
  - e. **Participates in maintenance operations of the AGS property**
  - f. Participates in a "show-and-tell" portion of a club meeting
  - g. Participates in any other club activity, as published by the Activities Chairperson, which is not mentioned above.
4. **Participates in maintaining the AGS field by signing the mowing list, if physically able.**

The meeting adjourned at 7:55PM to Kristophers' for hangar flying and food.


