Prez Sez - Brent Bryson

Aeroguidance Society Meeting #905

Dave Dewey-Wright filling in for Tom Fargo who is still recovering from back surgery.

Brent Bryson called the meeting to order at 6:30 p.m.

Treasurer's Report was presented by Bob Jennings. The annual audit was scheduled after the general meeting so that Jeff could take over all of the books. The account balance has increased as of the end of October due to income from regular Dues. It was noted that when paying by PayPal, the "send money" option should be used, otherwise PayPal takes a percentage of the payment. The Treasurer's report was accepted as presented.

A discussion of using the Pilot's building for the BOD meetings occurred, which requires a monthly payment.

Motion: by Jeff Hatton to pay for use of the Pilot's Association building.

Second: by David Dewey-Wright. Motion passed.

BOD meeting minutes were read.

Old Business -

Web site – DDW is working with Jeff Hatton to get access.

Field Closing – DDW to contact Todd to find out his plan.

New Business -

The BOD discussion regarding building up the road and needing new material was brought up. Based on the current condition of the road (relatively good) and the time of year (late), the discussion was tabled until Spring as we don't want to work up the road at this time of year. However, some work to make sure water from the field/runways goes across the driveway and not down the driveway will happen before winter. Jeff planned to take his backhoe up the following week.

Upcoming events -

January 1, 2024: New Year's Day Fun Fly – BC United Soccer Fields. Tentative approval to use the fields has been obtained, pending getting the insurance set up.

January 8, 2024: Holiday Party – A show of hands at the meeting expressed an interest in having an AGS Holiday Party. DDW said he would organize it, with the plan being to have it at Kristofer's.

March 9, 2024: Central Penn Aeromodelers Association RC Expo – Lebanon, PA. Ray Phillips indicated they're strongly encouraging everyone to buy tickets ahead of time so they don't need to have the ticket table at the entrance.

Post business presentation -

Harold Peeling talked about his project to move a SAFE/AS3X receiver from one plane to another. Simply moving it without programming updates made the new plane/receiver combination unacceptable. Not all SAFE receivers can be reprogrammed, but the AR636 and AR637 receivers can be. With the newer NX transmitters, the AS3X settings can be updated, but not the SAFE settings. He found a utility that allows both sets of settings to be updated. It's a bit tedious, but it worked reliably. He'll plan to demo the process at the next AGS meeting. If you're interested, please plan to show up!

Jeff Hatton brought the wings to his giant scale Extreme Flight YAK. He said that so far, he's very happy with the build quality. He'll be putting in a DA120 engine. He'd recently received the mufflers and headers and was working on getting those attached and installed. All of the wings and tail feathers have quick connects that don't require tools. Places where the fiberglass had been cut/milled can give you splinters and he is planning to go around those edges with CA to smooth them off. Jeff commented that the giant scale plane is less expensive than his pattern planes. He'll be flying it over at the Aero's field until he decides there's enough room on our runways to land it.

Motion by Ray Phillips to adjourn the meeting at 7:26

Second by Bill Green. The motion was carried.
