Session dates: Nov 14, 28: Dec 12: Jan 9, 23: Feb 13, 27: March 13, 27: April 10, 24.

Directions: Route 17 to exit 60. South on Route 220 about a mile to Athens exit. At exit left onto Pine St, straight thru red light at Elmira St. About ½ mi turn left onto Pennsylvania Ave (church on right). About ¼ mi turn left towards school and park on the far side of the school parallel to Pennsy Ave.

If school is cancelled due to weather or other reasons, the flying session is also cancelled.

Proposed changes to the AGS By -Laws

Current articles:

- 3.2 New Members Prospective new members become Associate Members for six (6) months by paying one half (1/2) of the annual dues, one half (1/2) of the field maintenance fee and the full amount of any Special Assessment, if required. Associate Members have all rights and duties of Regular Members except voting rights. During the seventh month, his membership shall be discussed and voted upon by secret ballot. Former Regular Members applying for membership shall be immediately eligible for Regular Membership at any regular meeting. A two-thirds (2/3) vote of a quorum (Refer to Article 4 Section 5) shall be required for Regular Membership.
- 9.9 As of January 1, 2006, persons applying for membership will be charged a field maintenance fee of one hundred dollars (\$100) payable in two installments, the first fifty dollars (\$50) paid after the person has been an Associate member for three months and the second fifty dollars (\$50) paid at the time the person becomes a Regular Member.
- 9.10 Special Assessments may be imposed upon the members of the AGS.2 These Special assessments must be for a defined purpose.
- 9.11 Special Assessments shall be approved by a two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.
- 9.12 Special assessments will not be levied on Student and Family Members. Field maintenance fees will not be levied on new Student Members, new Family Members, or former members.
- 9.13 Any member more than two (2) months delinquent in meeting his financial obligations may be removed from the AGS roles as provided for in Article 3.

Proposed changes:

- 3.2 New Members Prospective new members become Associate Members for six (6) months by paying one half (1/2) of the annual dues and the full amount of any Special Assessment, if required. Associate Members have all rights and duties of Regular Members except voting rights. During the seventh month, his membership shall be discussed and voted upon by secret ballot. Former Regular Members applying for membership shall be immediately eligible for Regular Membership at any regular meeting. A two-thirds (2/3) vote of a quorum (Refer to Article 4 Section 5) shall be required for Regular Membership.
- 9.9 Special Assessments may be imposed upon the members of the AGS.2 These Special assessments must be for a defined purpose.
- 9.10 Special Assessments shall be approved by a two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.
- 9.11 Special assessments will not be levied on Student and Family Members.
- 9.12 Any member more than two (2) months delinquent in meeting his financial obligations may be removed from the AGS roles as provided for in Article 3.

Rationale for the changes:

The proposed amendments to the by-laws reflect the elimination of the field maintenance fee.

The field maintenance fee, previously called the initiation fee, is believed to be the primary reason for a sharp drop in new members and its associated revenue.

The other area flying clubs are experiencing a normal rate of new membership.

The AMA has seen only a 4 % decrease in new membership this year.

This year the AGS has had the lowest membership rate ever recorded.

Prospective members with little or no experience have the greatest sensitivity to the field maintenance fee but their membership is essential to promoting model aeronautics within the AGS.
