

## **Proposed By-Laws Changes**

There are two proposed changes to our current by-laws, last updated September 2006. The intent is to vote on these two proposals separately at our next regular meeting. I remind you that our by-laws can be amended as follows:

### **Article XI - AMENDMENTS**

- A. Amendments may be made to the by-laws at any regular or special meeting of the membership, provided the members have all been notified in writing at least three (3) days in advance that an amendment is to be considered. Copies of the proposed amendment shall be provided to all directors or to any members who may request same. Approval shall be by two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.

Proposal 1 submitted by Jim Quinn:

Current Article IX

### **Article IX - DUES, FEES, and ASSESSMENTS**

- A. Dues will be imposed upon the members of the AGS in order to meet operating expenses.
- B. The dues year begins November 1st and ends the following October 31st.
- C. Dues are to be paid in advance at the October and April meetings. The amount paid at the October meeting is determined by dividing the total amount due (membership plus special assessment, as applicable) in half and rounding up to the nearest dollar, the balance being payable in advance at the April meeting.
- D. Regular Member dues shall be seventy-two dollars (\$72) per dues year.
- E. Senior Member dues shall be sixty dollars (\$60) per dues year.<sup>1</sup>
- F. Student Member dues shall be eighteen dollars (\$18) per dues year.
- G. Family Member dues shall be thirty dollars (\$30) per dues year. A Family Member who is a full time student or under the age of eighteen (18) shall pay the same dues as a Student Member.
- H. The total dues for a family living in the same household shall not exceed ninety-six dollars (\$96) plus special assessments.
- I. As of January 1, 2006, persons applying for membership will be charged a field maintenance fee of one hundred dollars (\$100) payable in two installments, the first fifty dollars (\$50) paid after the person has been an Associate Member for three months and the second fifty dollars (\$50) paid at the time the person becomes a Regular Member.
- J. Special Assessments may be imposed upon the members of the AGS.<sup>2</sup> These Special assessments must be for a defined purpose.
- K. Special Assessments shall be approved by a two-thirds (2/3) majority vote of a quorum at any regular or special meeting following written notification.
- L. Special assessments will not be levied on Student and Family Members. Field maintenance fees will not be levied on new Student Members, new Family Members, or Former Members.
- M. Any member more than two (2) months delinquent in meeting his financial obligations may be removed from the AGS roles as provided for in Article XVI.
- N. Any dues, fees, or special assessments paid to the AGS will not be refunded.
- O. All Officers and the Newsletter Editor, shall be exempt from paying one-half (1/2) of their dues while in office with the exception of the President who shall be exempt from paying any dues. All officers and the Newsletter Editor are subject to paying any and all Special Assessments.
- P. The club newsletter will be made available to the general public for a nominal fee to cover printing and mailing expenses. A subscription to the newsletter costs \$8.00 per year.

- G. Family Member dues shall be one dollar (\$1) per dues year.

## AEROBATIC PRIMER 2008

9:00: Instruction  
11:00 Flying  
12:30 Lunch*

The day will start at 9:00 with morning instruction and “dry flying of the maneuvers.” Several aerobatic pilots will be on hand led by Bob Noll. The Contest will start at 11:00 with a break for lunch around 12:30.

Now to the good part, the flying! AMA has issued a new set of maneuvers for the 2007/8 aerobatic season. This is true for all four of the AMA classes, Sportsman, Intermediate, Advanced, and Masters. The best way to get information about the new sequences is to go to the National Society Radio Control Aerobatics’ (NSRCA) website, [www.nsrca.us](http://www.nsrca.us). On the home page’s left margin there is a title, “Judging Rules” click on it. On the next page in the center, near the bottom will be four links, one for each of the AMA competition classes. Click on your sequence and you will get a wonderful description of each maneuver for each class.

Remember for the 2008 season is take offs and landings are now judged maneuvers. This year there will be down grades for a variety of reasons, as it had been in the past. Check the website for this information. Another significant development for 2008 is the “progressive” sequencing. Each level prepares you for the next higher level. For example, there is a 45 degree down line in all four sequences. In Sportsman it is just that 45 down. Intermediate it is 45 down with a ½ roll; Advanced has it with a snap and Masters has it with a snap and a half.

Lastly let me say I hope every member of the AGS comes to the primer. If you currently compete in AMA sanctioned contests as Masters, or FAI come as a judge and helper. Everyone else should come and fly. Bring your favorite airplane, the one you like to fly most often and the one you fly the best. I guarantee you will finish the day a better pilot. You may not come in first place, but you will be a better pilot. We all fly STRAIGHT and LEVEL, or so we think. That is the second maneuver in the Sportsman Sequence, right after TAKE OFF. Flying truly STRAIGHT and LEVEL takes a lot of skill. Come to the contest you will leave a better pilot. OH! Did I mention free food? Actually, it is not free, it is included in the entry fee of \$20.00.


