#### **Old Business:**

Club Charter has been sent to the AMA. New requirement is to provide field information regarding controlled/uncontrolled airspace status.

Lebanon RC swap meet is this coming Saturday, March 9<sup>th</sup>. Several AGS members will be attending.

Bob Jennings noted the Field rules on the website are out of date. Scott Wallace took the action to provide the most current Field rules to the webmaster.

Ray Phillips requested the Board provide a financial projection for the year, will be discussed at the next Board meeting. Brent Bryon brought the remaining AGS Library items in for one last chance to claim items, remaining items will be disposed of.

AMA has indicated the AMA Expo East (formerly WRAMs) show just concluded will be the last one held in NJ. No other info available at this time.

#### **New Business:**

Rick Allabaugh and Bob Noll discussed in general terms some ideas for increasing club membership. They met with AMA's Tony Stillman at Expo East and gained some insight into ideas that have been successful for other clubs. Bob mentioned he will discuss his plans with the Board at the next BoD meeting.

Bob Noll reviewed the AMA's Leader Member Minutes, a few key discussion points:

- FAA Reg # is required on your aircraft
- Club Safety Coordinator's roles and responsibilities
- Be aware that scammers have established 'fake' websites pretending to be the FAA registration websites in order to steal personal information & credit card numbers.

Ray Phillips provided an overview of the article in Model Aviation regarding LAANC (Low Altitude Authorization and Notification Capability). Ray emphasized that the AGS Field is not controlled airspace. However, questions on LAANC are certain to be on the FAA knowledge tests that will be coming. King Schools offers a free 15 minute course that is well worthwhile. You will have to set up an account with King Schools. This is no cost and they keep a record of completed courses.

#### Show and Tell:

Neil Hunt showed a set of plans for a MK "Blue Angel" classic pattern model he will be building. The Blue Angel is a beautiful pattern model and the original was flown to 1<sup>st</sup> place in the 1973 World Championships by Tsugutaka Yoshioka. Plans were printed locally by Data Flow.

#### **Program:**

Nothing formal, a general discussion was held focused on the FAA and impacts on the hobby.

Meeting was adjourned at 7:30

The AGS Board recommends the following Field Rule updates be implemented. Please come to the April meeting to discuss and vote on the proposed changes. The existing rule is shown in black above the proposed change version in red.

Under "General:"

3. Only pilots and their helpers shall be allowed in front of the chain link fence. Spectators shall remain behind the chain link fences at all times.

3. Only pilots and their helpers shall be allowed in front of the chain link fence. A helper is defined as an AMA/MAAC member. Spectators, visitors, and non-AMA/MAAC family members shall remain behind the chain link fences at all times. The chain link fence defines the AGS Safety Line. For specific events where the regular AGS field layout is modified (e.g. for the AGS Pattern Contest), the Contest or Event Director shall establish and enforce the Safety Line.

5. The maximum sound level emitted by any model shall be limited to 96 dB on the A weighted scale measured at 9'. New aircraft shall be tested and, if necessary, corrected promptly.

5. The maximum sound level emitted by any model flown at the AGS field shall be limited to 96 db. It is the model owner's responsibility to make corrective action to a model exceeding these limits. Glow engines larger than .049 and all gasoline engines shall be required to have an effective muffler; "flow through" style mufflers are not allowed.

10. Aircraft in the pit area shall be restrained as follows:

a. Aircraft powered by glow engines shall be restrained when the starting battery is attached.

b. Aircraft powered by electric motors shall be restrained when the batteries are connected. Note: Electric aircraft must have a visible means (able to see without touching) of showing the motor is disconnected when not physically restrained.

c. Aircraft powered by gasoline engines shall be restrained when the ignition battery is energized.

Propose adding as new rule #11 with photo map of the field, will roll all following numbers in the General Flying section

11. Flying over the Pit, Spectator or Parking areas is prohibited; these areas are illustrated in the map below. Additionally, all flying shall take place over unpopulated areas. Flying in the vicinity of our neighbors' homes shall be avoided.

#### Under "General Rules for Flying:"

5. A runway is closed to flying if maintenance is being performed anywhere on the runway side of the of the spectator line for that runway. Note: that restriction may allow flying on the other runway, but only on the runway side of the safety line.

5. When maintenance or mowing is being performed at the field, the pilots and maintenance workers present must develop a mutual plan of operations to ensure everyone's safety. This plan may include closing the field during maintenance or mowing. The mowing or maintenance crew chief has the final authority in these cases.

#### **Drawing Reproduction – by Rick Allabaugh**

Many of us like to get copies of plane plans when building a kit or scratch building. We typically go to Staples or even Kinko's to get copies. In my business, we use a company called Dataflow for drawing reproduction. They can handle standard reproduction, enlargements, and reductions. You would just need to tell them what percentage you need a plan increased or decreased. A standard reproduction would be on bond paper which they can print out 36" wide by any length. If you want a better quality copy that you can keep indefinitely, you may want to try a Mylar copy. It's more of a light plastic type material that will not degrade over time like paper. Dataflow can print out Mylars 36" wide x 120" long. Dataflow is located at 19 South Washington Street, Binghamton, NY, 13903 and their telephone number is (607) 772-2001. If you have any questions, I would suggest you talk with Colleen Horan. She's great to work with. Since Dataflow is a large production house, it may take a few days for them to make the copy. As always, when you are looking to use them, make sure they are clear on what you want and you are clear on cost. I think they tend to be less expensive than Staples or Kinko's and have better quality reproduction.

Finally, if you have a digital file, they can print that out for you too. Just make sure you are clear on what digital format you have. I typically send them PDF's.
