A motion was raised by David, seconded by Chris, and passed by members authorizing a raise to \$180 a year for the building rental. Ray will update us on the status of the building. If the Pilots' Association doesn't keep the building, the AGS will most likely have to find another place to hold meetings. The road to the shed was brought up due to the grass being too wet for anyone to drive on it. Bill suggested turning it into a gravel road. Bob said we could also put a trench pipe underneath it. The members agreed this was a good idea. Chris said he would find out how much a pipe would cost and let us know. Ray said the Ford tractor is running, but still needs a few things, including timing the engine. Bill and Ray stated that they were planning to time the engine and clean the air filter in the coming week. Chris said that if we are still having tractor problems, we should look into inviting the local tractor club to come up and check the Ford out for free. They would probably even mow some land for us. This would be beneficial to them for learning exercises for their members. Bill said the brush hog is still inoperable, so even if the tractor is running, we are unable to use that attachment. Dave stated he would contact Jeff and use his Kubota to lift up the brush hog so they could repair it.
